In the LCAP and ELO plan, Manzanita has always involved all stakeholders input in developing goals and actions to be taken to achieve those goals. Manzanita has a parent-run, parent-elected school board and they are consistently involved in every aspect of developing school policies and plans. Manzanita has continually engaged with all stakeholders through sharing information, collaborating, gathering input, membership meetings, staff meetings, conversations (pickup/drop off days), and the parents are engaged in all decision-making throughout the year. In March 2021, approximately 64% of our parents completed a survey that included options for expanded learning. The survey results were consistent with ongoing conversations among all stakeholders.

At the back to school held in person on September 29,2021 the staff, parents, and students were surveyed about possible options for the ESSER III funds.

#### A description of how the development of the plan was influenced by community input.

In Manzanita's LCAP, it was determined that Manzanita's focus would be on two goals. 1. Improve student engagement and rebuild school culture. 2. Support students academically, specifically in English Language Arts (ELA) and Math as well as increased Social Emotional Support (SEL).

A brief summary of feedback provided by specific stakeholder groups.

Parents: Most parents were interested in increased support for ELA and Math, including expanded learning opportunities. They were also interested in improving engagement and attendance.

Students: Students wanted more extracurricular and engagement opportunities.

Staff: Agreed with parents and students, recommending that academic support and SEL be increased both during and after school.

In March 2021, approximately 64% of our parents completed a survey that included options for expanded learning. Families interested in participating in a summer program were mostly interested in Math and English support, as well as opportunities for supervised and structured, engaging social activities. The survey results were consistent with ongoing conversations among all stakeholders.

Considering the improvements related to the county COVID-19 cases, more families have expressed interest in having their students participate in an in-person summer program. On a more recent survey, in which data is still being collected, twice as many families have expressed that they would like our summer program to have a high-focus on intentionally designed opportunities for social engagement and study trips as those interested in Math and/or ELA support.

In addition to parent and student input, staff members have had ongoing discussions regarding expanded learning opportunities. Conversations have focused on progress monitoring data, student engagement during remote learning, teacher observations, and conversions with families and students. Staff members unanimously agree that the summer program will need to be a balance of academic support for math and English combined with enrichment activities that strategically provide opportunities to support emotional and social development. Staff also suggests that academic support in ELA and Math will need to be provided as part of a before and/or after school program for the upcoming 2021-2022 school year, with additional in-class support for targeted students

# ESSER III Expenditure Plan Instructions

## Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;
- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
